Merger Integration Teams Begin Work

Last week the merger integration teams from AGL Resources and Nicor met in Atlanta to begin the process of determining how to most effectively join our companies. I want to thank everyone at Ten Peachtree Place for so warmly welcoming our Nicor colleagues. In their two days together, team members enjoyed the opportunity to get to know one another, learned more about each company's history and culture, and gained a better understanding of the significant challenge ahead.

With subject matter experts from both companies at the table, the team members will work together over the next several months to plan for the integration of the companies in a manner that establishes a solid platform for future growth. The integration planning process will be a rigorous one, yet it will be flexible enough to adapt to what the teams learn along the way. Team members will now enter the first phase of the process, which involves gathering data over several weeks in order to capture and analyze current state metrics, financials and operating models – in other words, to develop a solid understanding of how both companies currently do business. Exceptional diligence and accuracy in this phase is particularly important. The information gathered will serve as the foundation for the next step of designing and recommending optimal operating models for all functional areas of both the regulated and unregulated businesses.

As the integration planning process evolves, team members will evaluate a range of integration strategies as they determine how we will blend the best of both companies. In some functional areas, it may make the most sense to preserve the way business is being done today with little change proposed. In others, combining key elements of the operations of both companies into a new model may prove to be the most strategic option. And in still others, we hope to have the opportunity to transform the business by designing models that stretch the boundaries of what either company can accomplish today on a standalone basis and set the stage for a new era of growth.

The time commitment on behalf of the integration team members is considerable – and it would not be possible without your focus on day-to-day responsibilities that ensure we continue to deliver safe, reliable service to our customers. Your ongoing contributions are extremely important to the integration planning process.
