ITEM 1. SECURITY AND ISSUER

The class of securities to which this statement relates is common stock, par value \$.0001 per share (the "Common Stock") of StarCom Wireless Networks, Inc., a Delaware corporation (the "Company"). The address of the principal executive offices of the Company is 7318 Point of Rocks Road, Sarasota, Florida 34242.

The undersigned hereby supplements and amends the Schedule 13D dated June 2002, as amended (the "Statement") filed in connection with the Common Stock, of the Company as follows (reference is made to the Statement for previously reported facts).

ITEM 2. IDENTITY AND BACKGROUND

(a)-(c) Gary L. Brown and Lisa Brown, as joint tenants, 7318 Point of Rocks Road, Sarasota, FL 34242 is President and Director of the Company.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Item 3 is amended by adding thereto the following:

On July 18, 2003, Mr. Brown purchased in an open market transaction 10,000 shares at a price of \$.56 per share. Mr. Brown used personal funds for the purchase.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER

Item 5 is amended by adding thereto the following:

(a) Mr. Brown would be deemed the beneficial owner of an aggregate of 3,217,236 shares of the Issuer's common stock, which shares consist of (i) an aggregate of 2,517,236 shares of common stock owned by Mr. Brown in joint tenancy with his spouse, (ii) an aggregate of 100,000 shares of common stock owned by Mr. Brown's spouse, Lisa Brown, individually, and (iii) an aggregate of 600,000 shares of common stock owned in equal parts by Mr. Brown's two minor children. The 3,217,236 shares of common stock of which Mr. Brown would be deemed the beneficial owner represent 38.0% of the total issued and outstanding shares of common stock of the Issuer.

(b) Mr. Brown exercises the shared voting and dispositive power with respect to all the shares identified in Item 5(a) above with his wife, Lisa Brown.

(c) Mr. Brown effected the following transactions in the Issuer's securities covered by this Report:
