Item 7.01 Regulation FD Disclosure.

As previously announced, on January 22, 2018, FirstEnergy Corp. (the Company) entered into an agreement (the Preferred SPA) for the private placement of 1,616,000 shares of mandatorily convertible preferred stock. Pursuant to such agreement, the Company formed an advisory restructuring working group (the RWG) comprised of three of the Company's designees and two other members identified in the Preferred SPA. Also as previously announced, on August 26, 2018, the Company, two groups of key FirstEnergy Solutions Corp. (FES) creditors (the FES Creditor Groups), FES and its subsidiaries and First Energy Nuclear Operating Company (FENOC and, together with FES and its subsidiaries, the FES Debtors) and the official committee of unsecured creditors (the Unsecured Creditors Committee) appointed in connection with the FES Debtors' petitions for relief under Chapter 11 of the U.S. Bankruptcy Code filed with the U.S. Bankruptcy Court for the Northern District of Ohio in Akron (the Bankruptcy Court) entered into a definitive settlement agreement (the Settlement Agreement). The Settlement Agreement, which remains subject to approval of the Bankruptcy Court and satisfaction of the conditions set forth therein, would resolve all outstanding disputes with respect to the claims and causes of action among the Company and its non-debtor subsidiaries, on the one hand, and the FES Debtors, the FES Creditor Groups, and the Unsecured Creditors Committee, on the other hand. There can be no assurance that the Settlement Agreement will be approved by the Bankruptcy Court and, even if approved, whether the conditions to the settlement will be satisfied. On September 20, 2018, the Company and affiliates of Elliott Management Corporation (collectively, Elliott) mutually agreed pursuant to the Preferred SPA to terminate the RWG effective as of such date in light of the substantial completion of the RWG's role and not due to any disagreement between any member of the the RWG and the Company or its management.

conditions within our territories, assessment of the reliability of our transmission and distribution system, or the availability of capital or other resources supporting identified transmission and distribution investment opportunities; the ability to accomplish or realize anticipated benefits from strategic and financial goals, including, but not limited to, the ability to grow earnings in our regulated businesses, continue to reduce costs through FE Tomorrow, the Company's initiative launched in late 2016 to identify its optimal organization structure and properly align corporate costs and systems to efficiently support a fully regulated company going forward, and other initiatives, and to successfully execute our financial plans designed to improve our credit metrics and strengthen our balance sheet; the risks and uncertainties associated with litigation, arbitration, mediation

and like proceedings; the uncertainties associated with the deactivation of our remaining commodity-based generating units, including the impact on vendor commitments, and as it relates to the reliability of the transmission grid, the timing thereof; costs being higher than anticipated and the success of our policies to control costs; the uncertainty of the timing and amounts of the capital expenditures that may arise in connection with any litigation, including New Source Review litigation, or potential regulatory initiatives or rulemakings; changes in customers' demand for power, including, but not limited to, changes resulting from the implementation of state and federal energy efficiency and peak demand reduction mandates; economic and weather conditions affecting future sales, margins and operations, such as significant weather events, and all associated regulatory events or actions; changes in national and regional economic conditions affecting the Company and/or our major industrial and commercial customers, and other counterparties with which we do business; the impact of labor disruptions by our unionized workforce; the risks associated with cyber-attacks and other disruptions to our information technology system that may compromise our generation, transmission and/or distribution services and data security breaches of sensitive data, intellectual property and proprietary or personally identifiable information regarding our business, employees, shareholders, customers, suppliers, business partners and other individuals in our data centers and on our networks; the impact of the regulatory process and resulting outcomes on the matters at the federal level and in the various states in which we do business, including, but not limited to, matters related to rates; the impact of the federal regulatory process on Federal Energy Regulatory Commission (FERC) regulated entities and transactions, in particular FERC regulation of PJM Interconnection, L.L.C.
