This filing relates to a planned merger (the "Merger") between Hewlett-Packard Company ("HP") and Compaq Computer Corporation ("Compaq") pursuant to the terms of an Agreement and Plan of Reorganization, dated as of September 4, 2001 (the "Merger Agreement"), by and among HP, Heloise Merger Corporation and Compaq. The Merger Agreement is on file with the Securities and Exchange Commission as an exhibit to the Current Report on Form 8-K, as amended, filed by Hewlett-Packard Company on September 4, 2001, and is incorporated by reference into this filing.

The following is a letter to HP retirees from Susan D. Bowick, HP's Vice President and Director, Corporate Human Resources.

Dear HP retiree:

Hewlett-Packard has received a number of inquiries from people asking about the status of retiree medical benefits. Many of the inquiries have focused on a statement in the HP/Compaq merger agreement, which was reprinted in the HP/Compaq joint proxy, indicating that HP provides no retiree medical benefits. The statement was a standard, legal boilerplate that is common in merger agreements. Coverage under any HP benefit plan is determined by the terms of the plan in question and not by the terms of the merger agreement.

To avoid any confusion, let me be perfectly clear: The HP retiree medical benefits program will continue for current retirees after the merger.

We fully understand the confusion caused by the language in the merger agreement. The language is unfortunate, but legally required. That's why we felt it was important to send this letter to you and remove any confusion.
