**ITEM 7.01 REGULATION FD DISCLOSURE**

On December 14, 2005, Integrated Electrical Services, Inc. issued a press release announcing that (i) it has reached a non-binding agreement in principle with an ad hoc committee, whose members hold a majority of the company's 9-3/8% senior subordinated notes due 2009, for a proposed consensual restructuring of the company's capital structure; (ii) it has divested the majority of the assets of one of its commercial and industrial business units based in South Carolina for a gross sales price of \$7.1 million; (iii) it expects to file a Form 12b-25 with the SEC, which provides for a fifteen day extension on filing its Form 10-K for its fiscal year ended September 30, 2005; and (iv) it has rescheduled the release of its fiscal 2005 fourth quarter and year end results.
