- (1) Option for 13,793 shares, originally vesting 1/3 per year for three years - 2/20/04, 2/20/05 & 2/20/06. Option accelerated 10/27/05 with 4,598 of these shares subject to a resale restriction agreement until 2/20/06.

- (3) This option was previously reported as an option for 9195 shares of common stock at an exercise price of \$32.62 per share, but was adjusted to reflect the 50% stock dividend declared by WCI on May 25, 2004, which was payable on June 24, 2004, to all holders of record of common stock on June 10, 2004. Accordingly, on June 24, 2004, the date the stock dividend was paid, the option became exercisable for 13,793 shares at an exercise price of \$21.75 per share.
