This Schedule is being filed with respect to 1,656,705.00 shares of MDC Partners, Inc. (the common stock) held by Weiss, Peck & Greer Investments, a division of Robeco USA, L.L.C. at December 31, 2006 for the discretionary account of certain clients. By reason of rule 13d-3 under the act Robeco may be deemed to be a beneficial owner of such common stock. To the knowledge of Robeco no person has the right to receive or the power to direct the receipt of dividends from or the proceeds from the sale of such common stock which represents more than 5% of the outstanding shares of the common stock referred to in item 4(b) hereof.

Effective January 1, 2007, Robeco, which was a Delaware limited liability company registered as an investment adviser under section 203 of the Investment Advisers Act of 1940, as amended, merged into its parent company, Robeco Investment Management, Inc. ("RIM"), a Delaware corporation also registered as an investment adviser. RIM has been the parent of Robeco since 2001. Accordingly, reference should be made to RIM (CIK #0001386060) for any future filings relating to the holding of shares of common stock described herein.
