**MECHEL ANNOUNCES ATTEMPTS TO PREVENT ITS PARTICIPATION IN THE MMK AUCTION**

**Moscow, Russia December 7, 2004**

Mechel Steel Group (NYSE: MTL) announces that a subdivision of the Ministry of Internal Affairs collected commercial information from its subsidiary, Mechel Trading House on December 6 and 7, 2004.

The company is certain that the events are the results of actions designed to prevent the participation of Mechel in the privatization auction of the government's 23.8% stake in Magnitogorsk Iron and Steel Works, due to be held on December 22, 2004.

Mechel has protested the actions against the company, organized by potential bidders for the government's stake in MMK, and will continue to avail itself of all legal avenues to defend its ability to participate in the auction.

The company notes that it conducts its business in accordance with all applicable legal norms. All of its divisions continue to operate as usual.
