Regulation FD Disclosure*

On June 14, 2005, the Office of the Comptroller of the Currency (the OCC), informed the Company s subsidiary First National Bank that, as of June 13, 2005, the OCC had terminated the Memorandum of Understanding (the MOU) between the OCC and First National, dated April 8, 2004, relating to Bank Secrecy Act/Anti-Money Laundering matters. The OCC stated that it had determined that First National had complied with its obligations under the terms of the MOU.
