Lisbon, Portugal, 7 March 2008 Portugal Telecom informs that as part of the share buyback programme under execution, it has the right to acquire an additional 20,919,219 shares through equity swap agreements.

The total number of own shares that PT currently holds through equity swap agreements is 84,311,005 shares, of which 20,640,000 shares were contracted under the previous share buyback programme. As a result, the number of outstanding shares, adjusting for equity swaps on own shares recognised in the balance sheet, is 941,488,995.

As part of the share buyback programme under execution, a total of 166,727,505 own shares has been acquired, equivalent to 14.77% of PT's share capital prior to the share capital reduction executed on 20 December 2007. The total amount returned to shareholders to date, through the share buyback programme under execution, totals 1,609 million euros.
