### **PART III NARRATIVE**

State below in reasonable detail why Forms 10-K, 20-F, 11-K, 10-Q, 10-D, N-SAR, N-CSR, or the transition report or portion thereof, could not be filed within the prescribed time period.

As previously disclosed, our preparation of financial statements for the fiscal year ended June 30, 2007 and the quarter ended September 30, 2007 initially was delayed because of errors we identified in our accounting for sales of installments receivable. After those errors were identified, the audit committee of the board of directors and our management determined to engage in a detailed review of other accounts in our financial statements.

The completion of our financial statements was further delayed as the result of our transition to a new independent registered public accounting firm, effective as of the fiscal year ended June 30, 2008. The new independent registered public accounting firm was appointed by the audit committee on March 12, 2008, as described in a current report on Form 8-K that we filed with the SEC on March 13, 2008.

We have now filed our annual reports on Form 10-K for the fiscal years ended June 30, 2007 and June 30, 2008, and our quarterly reports on Form 10-Q for the quarterly periods ended September 30, 2007, December 31, 2007 and March 31, 2008. However, as a result of the matters described above, including the detailed review directed by the audit committee, we have not yet been able to file our quarterly reports on Form 10-Q for the quarterly periods ended September 30, 2008, December 31, 2008, and March 31, 2009, and we also were not able to file our annual report on Form 10-K for the fiscal year ended June 30, 2009 by the applicable due date.

Due to the matters described in Part III above, we cannot provide at this time an estimate of the results of operations to be reflected by the earnings statements for the fiscal year ended June 30, 2009. We have previously announced selected preliminary financial results for the periods for which we have not yet filed the required periodic reports.

In our press release issued on July 9, 2009, we announced that our license bookings in the quarter ended June 30, 2009 were approximately \$59 million, and were down on a year-over-year basis. We further announced that our cash balance at June 30, 2009 was approximately \$122 million, compared to approximately \$127 million at the end of the third quarter of fiscal 2009.

In our press release issued on May 15, 2009, we announced that our license bookings in the quarter ended March 31, 2009 were approximately \$41 million, and were down on a year-over-year basis. We further announced that our cash balance at March 31, 2009 was approximately \$127 million, an increase compared to approximately \$123 million at the end of the second quarter of fiscal 2009.

In our press release issued on February 19, 2009, we announced that our license bookings in the quarter ended December 31, 2008 were approximately \$63 million, and were largely consistent with the year ago period. We further announced that our cash balance at the end of the second quarter of fiscal 2009 was approximately \$123 million, as compared to approximately \$134 million at the end of the first quarter of fiscal 2009.

The foregoing balances should be considered preliminary estimates pending completion of our financial statements for the quarters ended September 30, 2008, December 31, 2008 and March 31, 2009, and for the fiscal year ended June 30, 2009.
