Thus, shareholders should vote FOR the five dissident nominees Chase, Golub, Kurz, McManus, and Smith on the GREEN CARD.*

Change is coming to Hess to the benefit of all shareholders. We encourage everyone to disregard Hess s last-ditch, desperation tactics and focus on the opportunities ahead for this Company and its shareholders.
