This Registration Statement on Form S-8 is being filed by Heritage Commerce Corp, a California corporation (the Company or the Registrant ) to register an additional 1,250,000 shares of common stock, no par value (the Common Stock ), that have become available for issuance pursuant to the Heritage Commerce Corp 2013 Equity Incentive Plan (the 2013 Plan ).
