Warren Revocable Trust. Mr. Warren is a co-trustee of the trust and has sole voting and shared investment power.
 - (2) Mr. Warren's previously reported number of directly held shares was overstated by 11,254 shares.
 - (3) The option was granted for 4,330 shares on 05-09-1995 and became exercisable for 25% of the shares on each of the first four anniversaries.
