Performance Share Awards are paid in shares of common stock under the Amended and Restated 2010 Plan.
- (2) Includes 1,182.76 shares of common stock acquired by the reporting person under the dividend reinvestment feature of The Toro Company Direct Stock Purchase Plan (the "DRIP") since the date of his last report.
- (3) Includes 417.594 shares of common stock acquired by the reporting person under the DRIP since the date of his last report.
