- (1) RSUs granted under the PG&E Corporation 2014 Long-Term Incentive Plan. RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis.

Dividends are automatically invested in additional units at the election of the participant. These holdings have been trued up to conform to the RSP balance as of 3/1/18.

- (3) Employee stock options granted under the PG&E Corporation 2014 Long-Term Incentive Plan.

- (4) One-third of stock options is exercisable on the first business day of March 2019, 2020, and 2021.
