- (3) Directors. Each Deferred Stock Unit is the economic equivalent of one share of common stock. The Deferred Stock Units become payable upon the reporting person's termination of service as a Director.

The RSUs will vest upon the earlier of (i) May 31, 2018 or (ii) the date of the Company's next annual meeting of stockholders, in each

- (4) case subject to the terms of the Plan and applicable award agreement. Any fractional shares for these RSUs were paid in cash upon settlement.

- (5) The RSUs will vest upon the earlier of (i) May 3, 2019 or (ii) the date of the Company's next annual meeting of stockholders, in each case subject to the terms of the Plan and applicable award agreement. Any fractional shares will be paid in cash upon settlement.
