Oncolytics Biotech Inc. s Research Collaborators to Present Phase I Combination REOLYSIN®/Radiation Clinical Trial Data at AACR Conference

(Oncolytics) (TSX:ONC, NASDAQ:ONCY) announced today that an oral presentation covering preliminary results of its Phase I combination REOLYSIN®/radiation clinical trial will be made at the American Association of Cancer Researchers (AACR) annual meeting, to be held April 1-5 in Washington, D.C. The presentation, entitled Phase I trial of intratumoral administration of reovirus type 3 (Reolysin) in combination with radiation in patients with advanced malignancies will be delivered by Principal Investigator Dr. Kevin J. Harrington of the Targeted Therapy Laboratory, The Institute of Cancer Research, Cancer Research UK Centre for Cell and Molecular Biology and Honorary Consultant in Clinical Oncology at The Royal Marsden NHS Foundation Trust, London, UK.

Oncolytics researchers have demonstrated that the reovirus is able to selectively kill cancer cells and, in vitro, kill human cancer cells that are derived from many types of cancer including breast, bladder, prostate, pancreatic and brain tumours, and have also demonstrated successful cancer treatment results in a number of animal models. Phase I clinical trial results have indicated that REOLYSIN® was well tolerated and that the reovirus demonstrated activity in tumours injected with REOLYSIN®.
