(a) Amount Beneficially Owned:

As of the date of this filing, each Reporting Person may be deemed to be the beneficial owner of:

(i) 1,046,250 shares of Common Stock owned by Millenco LLC, a Delaware limited liability company ("Millenco") (formerly known as Millenco, L.P.) which shares are a constituent part of the Company's units ("Units"), of which Millenco holds 1,046,250. Each Unit consists of one share of Common Stock and one warrant ("Warrant"). Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$7.50. Each Warrant will become exercisable on the later of the Company's completion of a business combination or 12 months from the closing of the Company's initial public offering, and will expire five years from the date of the Company's prospectus, dated October 10, 2007, or earlier upon redemption. As of the date of this filing, the Company has not announced the completion of a business combination and therefore, the Warrants are not currently exercisable; and

(ii) 2,684,800 shares of Common Stock held by Millenco.

In addition to the 1,046,250 Warrants held by Millenco as a constituent part of the Units, Millenco holds an additional 1,093,700 Warrants, which are also not currently exercisable.

Note: Catapult Partners, Ltd., an affiliate of the Reporting Persons, holds 800,000 warrants, which are also not currently exercisable.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the manager of Millenco, and consequently may be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to have shared voting control and investment discretion over securities

deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the shares owned by Millenco.

6.9% of the Company's Common Stock (see Item 4(a) above), which percentage was calculated based on 54,112,000 shares of Common Stock outstanding as October 31, 2007, as reported by the Company on its Form 10-Q, dated November 16, 2007.
