This resulted in no change in the number of shares beneficially owned by Mr. Myers.
- After the transactions reported on this Form 4, Mr. Myers is the direct beneficial owner of 132,950 shares of Class A Common Stock, (5) including the 82,500 restricted shares referenced in footnote 4.
