Item 1. Security and Issuer.

This statement relates to the common stock, par value \$.0001 per share ("Common Stock"), of Sunningdale, Inc., a Delaware corporation (the "Company"). The address of the Company's principal

executive office is P.O. Box 177, Lingfield, Surrey RH7 6BZ, England.

### Item 2. Identity and Background.

(a) This Schedule 13D is filed by Charles K. Howe, individually, and as the co-trustee of The C.K. Howe Discretionary Settlement 2004 (the "Trust").

(b) Mr. Howe's business address is P.O. Box 177, Lingfield, Surrey, RH7 6BZ, United Kingdom.

(c) Mr. Howe is in the business of business consultancy.

(d) During the past five years, Mr. Howe has not been convicted in a criminal proceeding (excluding traffic violations and similar misdemeanors).

(e) During the past five years, Mr. Howe has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding, was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) Mr. Howe is a citizen of Great Britain.

### Item 3. Source and Amount of Funds and Other Consideration.

555,390 of the shares were issued to Mr. Howe, and 172,125 of the shares were issued to the Trust by the Company in exchange for the transfer and assignment of 242 shares and 75 shares, respectively, of Advanced Aluminium Group, Ltd., a corporation incorporated under the laws of the United Kingdom, pursuant to the terms of a Share Exchange Agreement, dated September 22, 2004. A copy of such agreement is attached hereto as an exhibit.

### Item 4. Purpose of Transaction.

Mr. Howe acquired the shares pursuant to the Share Exchange Agreement. The purpose of the acquisition and the exchange was for the Company to obtain 100% ownership of Advanced Aluminium Group, Ltd, which has business operations in the United Kingdom.

Mr. Howe does not have any plans or proposals which relate to or would result in: (a) the acquisition by any person of additional securities of the Company; (b) an extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Company or any of its subsidiaries; (c) a sale or transfer of a material amount of assets of the Company or of any of its subsidiaries; (d) any change in the present board of directors or management of the Company, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board; (e) any material change in the present capitalization or dividend policy of the Company; (f) any other material change in the Company's business or corporate structure; (g) changes in the Company's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any other person; (h) causing a class of securities of the Company to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association; (i) a class of equity securities of the Company becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Securities Act; or (j) any similar action to those enumerated above.

Item 5. Interest in Securities of the Company.

(a) Mr. Howe is the beneficial owner of an aggregate of 727,515 shares of Common Stock, representing approximately 31.7% of the total issued and outstanding shares of Common Stock. Mr. Howe is the beneficial owner of 555,390 shares, individually, and as co-Trustee of the Trust, he is the beneficial owner of 172,125 shares of Common Stock.

(b) Mr. Howe has the sole power to vote or to direct the vote, and sole power to dispose or direct the disposition of the 555,390 shares of Common Stock beneficially owned by him individually. Mr. Howe has shared voting power and dispositive power in his capacity as co-Trustee, of the 172,125 shares of Common Stock owned by the Trust.

(c) Other than the acquisition of the shares as reported in this Schedule 13D, Mr. Howe has not effected any transactions in the Common Stock of the Company in the past 60 days.

(d) To the knowledge of Mr. Howe, no other person is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of the shares owned by him individually. The beneficiaries of the Trust have the right to receive dividends from, and proceeds from the sale of the shares owned by the Trust.

(e) Not applicable.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer.

In connection with the transactions contemplated by the Share Exchange Agreement, the Company, each of the Stockholders that are parties to the Share Exchange Agreement (the "Stockholders"), and the Keating Reverse Merger Fund, LLC, executed and delivered a voting agreement. Pursuant to the terms of the voting agreement for the one year period following the closing, the KRM Fund shall have the right to nominate one director to the Company's board and each Stockholder agrees to vote all of their shares of Common Stock as may be necessary to elect that director during the one year period following closing. A copy of the voting agreement is attached to this Schedule 13D.
