(1) Hereinafter, "Class A Shares".

Restricted Stock Units (previously granted on March 5, 2005) will vest on the third anniversary of the date of grant, subject to potential accelerated vesting in specified circumstances. Upon vesting, each restricted stock unit represents the right to receive one Class A Share of the Issuer.

(3) These Restricted Stock Units of the Issuer, granted on May 2, 2007, will vest on the third anniversary of the date of grant, subject to potential accelerated vesting in specified circumstances. Upon vesting, each restricted stock unit represents the right to receive one Class A Share of the Issuer.

(4) Stock Appreciation Rights (previously granted on July 30, 2003) vest 1/3 on each anniversary of the grant date, expire four years from the grant date, and may be settled in cash.

(5) Canadian dollars.

(6) Stock Options of the Issuer (previously granted on June 11, 2003) vest 1/5 on grant, and 1/5 on each anniversary of the grant date, expiring five (5) years from the grant date.

(7) Stock Options (previously granted on April 28, 2006) vest over five (5) years from the grant date: 20% (5,000 options) on the first anniversary of the grant date, an additional 20% on each of the next four (4) succeeding anniversaries of the grant date, and expire ten (10) years from the grant date.

(8) These Class A Share Purchase Warrants form part of the Units issued by the Issuer.
