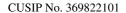

Jack Silver beneficially owns 2,032,610 shares of Common Stock of General Finance Corporation representing 16.3% of the outstanding Common Stock, based on 10,500,000 shares of Common Stock outstanding as reported by the issuer in its Quarterly Report on Form 10-Q dated August 13, 2007. Such shares of Common Stock beneficially owned by Mr. Silver include: (i) 342,500 shares of Common Stock issuable upon exercise of warrants held by Sherleigh Associates Inc. Defined Benefit Pension Plan, a trust of which Mr. Silver is the trustee; (ii) 1,590,110 shares of Common Stock issuable upon exercise of warrants held by Sherleigh Associates Inc. Profit Sharing Plan, a trust of which Mr. Silver is the trustee; and (iii) 100,000 shares of Common Stock held by Sherleigh Associates Inc. Defined Benefit Pension Plan, a trust of which Mr. Silver is the trustee.

Mr. Silver has the sole voting and dispositive power with respect to all 2,032,610 shares of Common Stock beneficially owned by him.
