On May 14, 2009, Clacendix, Inc. (the "Company") completed a share exchange transaction (the "Exchange") pursuant to the terms of a Securities Exchange Agreement, dated as of May 14, 2009 (the "Securities Exchange Agreement") with HealthWarehouse.com, Inc. ("HWI"). Under the Securities Exchange Agreement, the Company acquired all the outstanding capital stock of HWI. As a result of the Exchange, which was accounted for as a reverse recapitalization, HWI became a subsidiary of the Company, with HWI's former stockholders acquiring a majority of the outstanding shares of the Company's common stock. The Company changed its corporate name from Clacendix, Inc. to HealthWarehouse.com, Inc., following stockholder approval in accordance with applicable law. The Company succeeded to the business of HWI as its sole line of business.

During the quarter ended September 30, 2011, the Company relocated its corporate offices from 100 Commerce Blvd, Loveland, OH 45140 to its new headquarters at 7107 Industrial Road, Florence, KY 41042. This relocation caused a significant delay in the preparation of the form 10Q for the period ending September 30, 2011.

The Company is unable to file its Form 10-Q for the quarter ended September 30, 2011 within the prescribed time period because the Company is experiencing delays in collection and compilation of certain information which the Company believes is required to be included in the Form 10-Q, due to the lack of staff capable of assisting in the gathering of the required financial information. The Company's Form 10-Q will be filed on or before the fifth calendar day following the prescribed due date.

The Company anticipates a loss from operations of approximately \$(3,508,231) for the nine months ended September 30, 2011 as compared to a net loss of \$(1,924,103) for the nine months ended September 30, 2010. The reason for the change is that the Company's operating costs increased primarily due to costs relating to increased growth, primarily in salary and salary related expenses (increased headcount), freight costs, and advertising expenses. In addition, the Company accrued dividends payable to preferred shareholders for the nine months ended September 30, 2011 and none for the same period in 2010.
