## **OVERSEAS REGULATORY ANNOUNCEMENT**

### **Announcement on Issuance of**

### **Super Short-term Commercial Paper**

The Company and all members of the Board warrant that the information set out in this announcement is true, accurate and complete, and accept joint responsibility for any false information or misleading statements contained in, or material omissions from, this announcement.

China Eastern Airlines Corporation Limited (the “**Company**”) has completed the issuance of the 2016 first tranche of super short-term commercial paper of the Company (the “**2016 First Tranche SCP**”) on 18 January 2016. The issuance amount of the 2016 First Tranche SCP was RMB2.5 billion with a maturity of 90 days whereas the nominal value was RMB100 per unit and the annual interest rate was 2.50%.

China Development Bank and China Construction Bank Corporation, acting as the joint lead underwriters, formed an underwriting syndicate for the 2016 First Tranche SCP. The 2016 First Tranche SCP will be issued to institutional investors in public in the PRC interbank debenture market by way of book-building and centralised placing. The proceeds from the 2016 First Tranche SCP will be used principally to re-finance bank loans of the Company and to improve the debt structure of the Company. The relevant documents in respect of the 2016 First Tranche SCP are available at the websites of China Money ([www.chinamoney.com.cn](http://www.chinamoney.com.cn)) and Shanghai Clearing House ([www.shclearing.com](http://www.shclearing.com)).

The RMB2.5 billion 2016 First Tranche SCP was issued under the registered amount of the Company's super short-term commercial paper of not more than RMB20 billion (and with a term of not more than 270 days) pursuant to the "Notification on Acceptance of Registration" (Zhong Shi Xie Zhu 2014 No. SCP 131) from the National Association of Financial Market Institutional Investors. Such aggregate registered amount is effective within two years from the issuance date of the notification. The super short-term commercial paper may be issued in tranches within the effective period of registration.
