### G. WILLI-FOOD RECEIVES PURPORTED CLASS ACTION LAWSUIT; COMPANY BELIEVES CLAIMS ARE WITHOUT MERIT AND INTENDS VIGOROUS DEFENSE

YAVNE, ISRAEL - DECEMBER 11, 2006 - G. WILLI-FOOD INTERNATIONAL LTD. (NASDAQ: WILC) (the "COMPANY" or "WILLI FOOD"), one of Israel's largest food importers and a single-source supplier of one of the world's most extensive range of quality kosher food products, today announced that a purported class action lawsuit had been filed against the Company. The complaint alleges that the Company misled its customers by reducing the content in its tuna containers, and then charging its customers the same price as before. The complaint, if recognized as a class action, alleges damages of approximately NIS 23.5 million (approximately US\$5.6 million), including NIS 11.75 million (approximately US\$2.8 million) for return of the overcharge and NIS 11.75 million (approximately US\$2.8 million) for additional compensation.

The Company believes that the complaint is without merit and intends to vigorously defend against the litigation.
