Represents the settlement of performance share units (PSUs) that were granted under The NASDAQ OMX Group, Inc. Equity Incentive Plan on December 12, 2007. The ultimate amount of shares to be received under the grant depended upon the achievement of

- (1) performance goals during a one-year performance period from January 1, 2008 through December 31, 2008. On February 25, 2009, the Management Compensation Committee of NASDAQ OMX's Board of Directors approved the settlement of the PSU grant. The shares underlying the PSUs will vest on December 31, 2011.
- (2) Represents (i) 19,000 shares of common stock acquired upon exercise of vested options, (ii) 20,156 shares of restricted stock, of which 9,286 shares are vested, (iii) 16,527 unvested shares underlying PSUs and (iv) 1 share acquired under the Employee Stock Purchase Plan.
- (3) Represents exercisable options.
- (4) Represents exercisable options.
- (5) Options exercisable on December 17, 2012, subject to accelerated vesting on December 17, 2011, or extension of vesting until December 17, 2013, depending on the achievement of performance goals.
- (6) Options exercisable as to 50% on December 13, 2009 and as to 50% on December 13, 2010.
- (7) Options exercisable on December 12, 2010.
