- (1) The sale was effected pursuant to a Rule 10b5-1 trading plan initially adopted by the reporting person on February 25, 2010. The plan provides for the sale of a maximum of approximately 82,015 shares of common stock (based on estimated tax withholding upon RSU vesting). After the transaction reported on this Form 4, a maximum of approximately 49,982 shares remain available for sale under the plan (based on estimated tax withholding upon RSU vesting). The plan expires on the earlier of February 28, 2011, or the date all shares under the plan are sold.
- (2) These shares sold at prices ranging from \$11.11 to \$11.24 per share. Upon request by the SEC staff, the issuer or any security holder of the issuer, the reporting person will provide full information regarding the number of shares sold at each separate price.
- (3) The initial grant of a stock option for 105,000 shares of common stock vests according to the following schedule: approximately 33.3% vested on April 1, 2010, and approximately 16.7% vests at the end of each six-month period thereafter, such that the stock option will be fully vested on April 1, 2012.
