Mr. Buffett disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest therein.

(9) 4,197,569 of the total reported securities as of September 28, 2012, are owned by the following pension plans of Berkshire's subsidiaries: Acme Brick Company Pension Trust (175,000), The Buffalo News Office Pension Plan (65,000), The Buffalo News Mechanical Pension Plan (16,000), The Buffalo News Drivers/Distributors Pension Plan (7,000), The Buffalo News Editorial Pension Plan (105,000), Dexter Pension Plan (90,000), Flightsafety International Inc.
