(1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.

(2) The shares reported in the table above were previously reported pursuant to Section 16(a) of the Securities Exchange Act of 1934, as amended, by the reporting person "Pritzker Family U.S. Situs Trusts," which was comprised of a group of U.S. situs trusts and various entities owned, directly or indirectly, by U.S. situs trusts for the benefit of certain lineal descendants of Nicholas J. Pritzker, deceased, and their immediate family members. Thomas J. Pritzker, Marshall E. Eisenberg and Karl J. Breyer served as co-trustees of all such U.S. situs trusts until their resignation as trustees on November 30, 2012, at which time Lewis M. Linn was appointed successor trustee of the Reporting Person.

(3) This Form 3 is being filed in connection with the appointment of Mr. Linn as successor trustee and to report the Reporting Person's beneficial ownership on a stand-alone basis. Mr. Linn, solely in his capacity as trustee of the Reporting Person, has executed a joinder to the Amended and Restated Global Hyatt Agreement, and is thereby subject to the provisions of that agreement. Accordingly, immediately following the appointment of the successor trustee, the shares remain shares of Class B Common Stock.
