(1) The transactions reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on December 14, 2012.

The sale prices reported in column 4 of Table 1 represent the weighted average sale price of the shares sold ranging from \$86.59 to \$87.45 and \$87.60 to \$88.52, per share, respectively. Upon request by the Commission staff, the Issuer, or a security holder of the Issuer, the Reporting Person will provide full information regarding the number of shares sold at each separate price.
