Each special warrant is convertible into one common share and one-half of one common share purchase warrant for no additional consideration. Each special warrant is convertible at any time after 180 days from closing on June 5, 2007, and subject to automatic conversion in certain circumstances. Each warrant will entitle the holder to acquire an additional common share at an exercise price of \$1.10 for a period of five years from June 5, 2007.
