Item 3.02 Unregistered Sales of Equity Securities

On June 1, 2011, the Registrant accepted a conversion notice from Tangiers Investors LP, ("Tangiers") to fully satisfy a Convertible Promissory Note Agreement ("the Note") dated December 30, 2010 with Tangiers pursuant to which the Company received \$50,000 as a loan from Tangiers.

As set forth in the Company's Current Report on Form 8-K filed with the Securities and Exchange Commission on April 8, 2011, \$27,982.50 of the principal on the Note was partially satisfied on April 1, 2011 with the issuance of 975,000 restricted shares of common stock of the Company. The remaining amount outstanding on the Note as of April 8, 2011, was \$22,017.50 plus interest.

Pursuant to the terms of the Note, the Note is convertible to common stock, in whole or in part, at any time and from time to time before maturity at the option of the holder at the greater of (a) \$0.005 or (b) seventy percent (70%) of the lowest traded price of common stock out of the ten (10) trading days immediately preceding the conversion date. The Note has a term of one year and accrues interest at a rate equal to 9.9% per year. In accordance with the terms of the Note and receipt of the required conversion notice from Tangiers, the Note was converted into 462,416 restricted shares of common stock of the Company to satisfy the remaining \$22,017.50 of principal plus \$1,611.95 in accrued interest. The shares issued were valued at \$0.0511 per share, which was equal to 70% of the lowest traded price of our common stock out of the ten (10) trading days immediately preceding the conversion date. The shares were issued on June 1, 2011, and will remain restricted until at least June 30, 2011.

As of the date of this report, the aggregate balance due on all convertible notes issued to Tangiers has been reduced to zero, and the debt has been retired.

Tangiers is an "accredited investor" as defined under Rule 501 of Regulation D. The Company paid no fees or commissions in connection with the issuance of the Shares in satisfaction of the debt. The Company believes that this transaction is exempt from registration with the Securities and Exchange Commission pursuant to Section 4(2) of the Securities Act of 1933.
