Please find enclosed a Notification of interests filed pursuant to Section 67 of the Companies Act, 1990. This Notice is filed by The Capital Group Companies, Inc. ("CGC").

The Capital Group Companies, Inc. ("CGC") is a holding company for several subsidiary companies engaged in investment management business. The investment management business is divided into two operational groups, represented by Capital Research and Management Company ("CRMC") and Capital Group International, Inc. ("CGII"). CRMC is a U.S. - based investment adviser that manages The American Funds Group of mutual Funds, CGII is the parent company of five companies that serve as investment managers to various institutional clients around the globe; Capital Guardian Trust Company in the U.S. Capital International, Inc. in the U.S. and Singapore, Capital International Limited in the United Kingdom, Capital International S.A. in Switzerland and Capital International K.K. in Japan. Neither CGC nor any of its subsidiaries own shares of your company for their own account. Rather, the shares reported in this Notification are owned by accounts under the discretionary investment management of one or more of the investment management companies described above. Furthermore, CRMC and CGII act separately from one another and from CGC in exercising investment discretion over their managed accounts.

For the purposes of this Notification an outstanding share balance of 763,409,133 shares was used to calculate the percentages of holdings of the relevant share capital which determine the notifiable interest. We believe this outstanding share balance is current; however, if this number is not accurate, please contact us soon as possible so we may make the necessary revisions to this Notification.
