GlaxoSmithKline plc (the Company) announces that in accordance with the authority granted by shareholders at the Company's Annual General Meeting on 3 May 2012 it purchased 1,785,000 of its Ordinary Shares of 25 pence each (Shares) on 28 May 2012.
