By letter dated December 10, 2003, the Company reported that two holders of Company's Convertible Notes exercised their conversion rights. Hence, the financial indebtedness of the Company shall be reduced in US\$ 1,020,000 and an increase of 2,008,664 ordinary shares face value pesos 1 (V\$N 1) each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 131,503,308 to 133,511,972. On the other hand, the amount of registered Convertible Notes is US\$ 45,464,230.
