By letter dated April 1, 2004, the Company reported that on March 31, 2004 holders of Company s Convertible Notes that already had exercised their conversion right exercised their warrant rights. Hence, a reduction of 768,112 warrants and an increase of 1,512,624 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 148,186,374 to 149,698,998. The exercised of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6093 for each share face value pesos 1. Therefore US\$ 921,643 entered into the Company.
