ChipMOS REPORTS REVENUE FOR NOVEMBER 2004

Hsinchu, Taiwan, December 16, 2004 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (Nasdaq: IMOS) today reported unaudited consolidated revenue for the month of November 2004.

Revenue for the month of November 2004 was NT\$1,184.5 million (US\$36.8 million), an increase of 43.3% from NT\$826.4 million (US\$25.7 million) for the same period in 2003 and a decrease of 4.0% from NT\$1,234.0 million or US\$38.4 million for the month of October 2004. (All translations from NT dollars to US dollars were made at the exchange rate of NT\$32.16 against US\$1.00 as of Nov. 30, 2004.)

ChipMOS November 2004 consolidated revenue includes revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS Far East Limited, ChipMOS Logic TECHNOLOGIES INC., Advanced Micro Chip Technology Co., Ltd., CHANTEK ELECTRONIC CO., LTD., Modern Mind Technology Limited and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., ThaiLin Semiconductor Corp. and FIRST SEMICONDUCTOR TECHNOLOGY, INC..
