On April 1, 2005, DIMON Incorporated issued a press release announcing that, as part of its previously announced (1) cash tender offer for any and all of its outstanding (a) 9^{5/8}% Senior Notes due 2011 (the 9^{5/8}% Notes) and (b) 7^{1/4}% Senior Notes due 2013 (the 7^{1/4}% Notes) and, collectively with the 9^{5/8}% Notes, the Notes), and (2) solicitation of consents to amend each of the indentures governing the Notes, it is extending the expiration date of the tender offer. The extension of the tender offer is described in the press release, which is attached as Exhibit 99.1 to this Form 8-K and incorporated herein by reference.
