ChipMOS REPORTS JUNE 2005 REVENUE

Hsinchu, Taiwan, July 20, 2005 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of June 2005.

Revenue for the month of June 2005 was NT\$1,278.5 million or US\$40.4 million, a decrease of less than 1% from NT\$1,283.6 million or US\$40.6 million for the month of May 2005 and a decrease of 11% from NT\$1,439.6 million or US\$45.5 million for the same period in 2004. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$31.62 against US\$1.00 as of June 30, 2005.)

ChipMOS June 2005 consolidated revenue included revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS TECHNOLOGIES (H.K.) Limited (formerly ChipMOS Far East Limited), ChipMOS Logic TECHNOLOGIES INC., CHANTEK ELECTRONIC CO., LTD., Modern Mind Technology Limited and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., and ThaiLin Semiconductor Corp.
