By letter dated September 15, 2005, the Company reported that a holder of Company's Convertible Notes exercised it conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 10,000 and an increase of 19,692 ordinary shares face value pesos 1 each was made. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 163,031,351 to 163,051,043. On the other hand, the amount of registered Convertible Notes is US\$ 39,992,232.
