By letter dated April 25, 2006, the Company reported that a holder of Company s Convertible Notes exercised it conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 525,000 and an increase of 1,033,871 ordinary shares face value pesos 1 each was made. The conversion was performed according to the terms and conditions established in the prospectus at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion, the outstanding shares of the Company goes from 176,269,956 to 177,303,827. On the other hand, the amount of registered Convertible Notes is US\$ 35,098,881.
