By letter dated September 26, 2007, the Company reported that a holder of the Company s Convertible Notes exercised his conversion rights. Hence, the financial indebtedness of the Company shall be reduced in US\$ 24,294 and accordingly, a capital increase of 44,576 ordinary shares face value pesos 1 each has been made. The conversion was performed according to the terms and conditions established in the prospectus of issuance at the conversion rate of 1.83486 shares, face value pesos 1 per Convertible Note of face value US\$ 1. As a result of that conversion the amount of shares of the Company goes from 498,033,712 to 498,078,288. The amount of registered Convertible Notes is US\$ 860,464.
