As previously announced, i2 entered into an agreement and plan of merger with JDA Software Group, Inc. ( JDA ) and Iceberg Acquisition Corp. dated August 10, 2008. i2 scheduled a special meeting of stockholders for November 6, 2008 to vote on the merger, with the closing planned for the same date thereof. On November 4, 2008, JDA requested that i2 adjourn its November 6, 2008 stockholder meeting to allow the companies to negotiate a reduced purchase price to close the merger. On November 6, 2008, i2 held the meeting of stockholders and the stockholders approved the merger but the merger did not close. Due to the timing of the request by JDA and the fact that the merger with JDA did not close on November 6, 2008, i2 will be unable to finalize and file its Form 10-Q for the quarter ended September 30, 2008 by the due date. i2 intends to file its Form 10-Q by the fifth calendar day following the due date.
