**Hsinchu, Taiwan, June 19, 2009** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of May 2009.

Revenue for the month of May 2009 was NT\$961.2 million or US\$29.5 million, an increase of 2.2% from the month of April 2009 and a decrease of 38.5% from the same period in 2008. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.57 against US\$1.00 as of May 29, 2009.)
