EXPLANATORY NOTE

This Registration Statement on Form S-8 is being filed for the purpose of registering an additional 2,000,000 shares of the Registrant's common stock, par value \$0.01 per share (the "Common Stock"), that may be issued pursuant to the employer stock fund under the EMC Corporation 401(k) Savings Plan, as amended (the "Plan"). Pursuant to General Instruction E to Form S-8, the contents of the earlier registration statements on Form S-8 concerning the Plan filed with the Securities and Exchange Commission (the "Commission") on June 19, 1998 (File No. 333-57263), March 28, 2003 (File No. 333-104114) and July 16, 2008 (File No. 333-152368), are incorporated herein by reference, except to the extent supplemented or amended or superseded by the information set forth herein.
