<b>Series:</b>	The Notes are part of a series of debt securities entitled Medium-Term Notes, Series A that we may issue under the Indenture. We may reopen this series of Notes, and issue additional Notes of this series, under the Indenture in the future.
<b>Interest Payment Dates:</b>	Interest will be paid semiannually on May 15 and November 15, beginning on May 15, 2013, to holders of record as of the preceding May 1 and November 1, respectively.
<b>Day Count:</b>	30/360
<b>Use of Proceeds:</b>	The net cash proceeds from the sale will be used for general corporate purposes. Pending such use, we may temporarily invest net proceeds in interest-bearing, investment-grade securities.
<b>Optional Redemption:</b>	The Notes are not redeemable prior to November 15, 2014. Commencing November 15, 2014, the Notes may be redeemed in whole, but not in part, on such date or on any interest payment date thereafter. Zions Bancorporation will provide notice, in writing, of the optional redemption not less than five business days before the redemption date.
<b>Redemption Price:</b>	100% of the principal amount of the Notes being redeemed plus accrued interest thereon up to, but not including, the redemption date.
<b>Exchange Listing:</b>	We have not determined whether we will file an application to list the Notes on the New York Stock Exchange. However, in the event that we elect to file such an application, there can be no assurance that the NYSE will approve the Notes for listing.
<b>Denomination:</b>	We will issue the Notes in denominations of \$1,000 and in integral multiples thereof.
<b>Book-Entry System:</b>	The Notes will be issued only in fully registered form without interest coupons. Beneficial interests in the Notes will be shown on, and transfers of those beneficial interest can only be made through, records maintained by The Depository Trust Company and its participants.
<b>Auction / Distribution Agent:</b>	Zions Direct, Inc.
<b>Trustee:</b>	The Bank of New York Mellon Trust Company, N.A.
<b>Authenticating / Issuing / Paying Agent:</b>	Zions First National Bank
<b>Settlement Date:</b>	It is expected that the delivery of the Notes will be made against payment for the Notes on November 5, 2012, which is the third business day after the allocation of the Notes by our auction agent (the settlement cycle being referred to as T+3).
