At the Annual Meeting of Stockholders held on June 10, 2015, the stockholders voted on the following three proposals:

1. Election of Theodore Stern, Paul Jarman, Steve Barnett, Mark J. Emkjer, Blake O. Fisher, Jr., Paul F. Koeppe, and Hamid Akhavan as directors of inContact to serve until their successors are duly elected and qualified;
2. Approve an amendment to inContact's 2008 Equity Incentive Plan to increase the number of common shares available for awards under the Plan by 2,000,000 to a total of 9,772,500 shares; and
3. Ratify the Audit Committee's appointment of Deloitte & Touche LLP as inContact's independent registered public accounting firm for the year ending December 31, 2015
