**Glass Lewis Joins Leading Proxy Advisory Firms in Advising Anthem Shareholders to Vote For Cigna Acquisition**

INDIANAPOLIS--([BUSINESS WIRE](#))--Nov. 23, 2015--Anthem, Inc. (NYSE:ANTM) today announced that Glass Lewis & Co. ( Glass Lewis ), a leading independent proxy advisory firm, has joined Institutional Shareholder Services ( ISS ) and Egan-Jones Proxy Services ( Egan-Jones ) in recommending that Anthem shareholders vote to approve the issuance of Anthem stock in the proposed acquisition of Cigna Corporation (NYSE: CI) at the company's Special Meeting of Shareholders on Thursday, December 3, 2015.

The three leading proxy advisory firms have now independently acknowledged the compelling near- and long-term value of Anthem's acquisition of Cigna, said Joseph R. Swedish, President and Chief Executive Officer, Anthem. We are pleased that Glass Lewis, like ISS and Egan-Jones, has recommended shareholders vote in favor of a combination that will be uniquely positioned to meet the challenges of the unprecedented transformation in healthcare. The Anthem and Cigna businesses are highly complementary with limited overlap in the geographies and market segments in which we operate. Together, Anthem and Cigna will be better able to increase access to high quality, affordable healthcare, accelerate innovation and enhance collaboration with providers to focus on improved patient outcomes.

Anthem's Board of Directors unanimously recommends that Anthem shareholders vote FOR the proposal to issue Anthem common stock to acquire Cigna, which is necessary to complete the transaction.

Anthem's Special Meeting of Shareholders is scheduled to take place on Thursday, December 3, 2015, at 8:00 a.m. Eastern Standard Time ( EST ). The meeting will be held at the Conrad Hotel at 50 W. Washington St., Indianapolis, Ind. Anthem shareholders of record at the close of business on October 22, 2015 will be entitled to vote at the special meeting.
