**Item 7.01 Regulation FD Disclosure.**

On March 22, 2016, MGM Growth Properties LLC ( MGP ), a subsidiary of MGM Resorts International (the Company ) filed a Registration Statement on Form S-11 (the Registration Statement ) with the Securities and Exchange Commission (the SEC ). The Registration Statement disclosed certain information that supplements or updates certain prior disclosures of the Company. Pursuant to Regulation FD, the Company is furnishing herewith such information, excerpted from the Registration Statement, as Exhibit 99.1 to this Form 8-K (the Supplement ).
